Functional Capacity Evaluations:

- Accepted as an expert witness in the Supreme Court of British Columbia for testimony related to work/functional capacity evaluation, cost of future care analysis, and occupational therapy
- Able to perform both physically-based & cognitively-based functional capacity evaluation whilst considering the physical, cognitive, & emotional factors that influence function
- Experienced using standardized, evidenced-based functional testing equipment
- Able to use job demands & task analysis to develop meaningful & specific work simulation activities to incorporate in functional testing

Cost of Future Care / Life Care Planning Evaluation:

- Able to use task analysis to evaluate an individual's capacity for performing a variety of homemaking activities, including house cleaning & yard work
- Able to interpret functional test measures & determine capacity for homemaking
- Able to identify need for temporary or permanent accommodations within the home with an aim of restoring independent function, whenever possible, or alternatively providing recommendations, including services, supplies & equipment, to restore the level of independent function that was present prior to the onset of impairment/disability

Return-To-Work Support Services:

- Able to coordinate & lead return to work meetings with involved stakeholders
